MINUTES

1. **APOLOGIES** - Nil

IN ATTENDANCE: Julia Chernoukha (Womens Council Chairperson); Taleah Neowhouse (Competitions Manager); Adam Giles (Referees Manager); Coogee; Dunbar Rovers; Glebe Wanderers; Maroubra Utd; Mascot Kings; Queens Park; Waverley Old Boys ;

ABSENT: Heffron Hawks; Lokomotiv Cove; Maccabi Hakoah; Olympic Eagles; Pagewood; UNSW;

Taleah introduced Adam Giles to meeting. Adam will be replacing Taleah as the Acting Competitions Manager as of the 19th July.

2. **AMENDMENTS TO PREVIOUS MINUTES**

Dunbar requested the following inaccuracies in the Council meeting to be change:

Item 3, Paragraph 14: Clubs were asked their views and commented on the new Pagewood team entering AAW1, not generically in the competition. Dunbar have no objection to this side entering AAW2, but the minutes do not read that way.

Clubs agreed to reword the paragraph:

“Dunbar and Queens Park do not object to the AAW1 side entering the AAW2 competition but would prefer the players to be split amongst clubs needing players”

Queens Park proposed the change and Glebe second the change.

Item 5, Paragraph 2: The minutes suggest that Dunbar is unable to assist with the fundraising activit, however Andrea personally was unavailable and not in a position to delegate someone without a discussion with them first.

Clubs agreed to delete the paragraph

Item 5, Paragraph 4: The minutes implied that Dunbar had some authority of Centennial Parklands ground usage. This is not the case and Dunbar merely suggested Centennial Parklands as it has multiple pitches.

Clubs agreed to delete the paragraph from the minutes.

3. **PROPOSAL BY QUEENS PARK “PAGEWOOD AAW1 TEAMS”**

Queens Park placed the item on the agenda to question what has happened with the Pagewood AAW1 second team as they have been turning up to games with no players.

Julia mentioned to clubs that she had got Taleah to check the match sheets for both the AAW1 and AAW1a teams on the request from clubs and there was nothing wrong with the match cards. Julia mentioned that there were 5

additional players that were moved from the original team to the second team.

Queens Park questioned the first team stating that they are not the same team as they had originally played in the first round. Pagewood mentioned that they had always been a good team but had a slow start.

Maroubra raised concern that Pagewood had dropped the players from the original team to sacrifice the other team. Clubs discussed the situation.

Waverley questioned Pagewood on how many players they have in both teams. Pagewood answered that they have 16 players in each team.

Glebe were alarmed as they believed that the second team was a whole new team. Taleah explained that Pagewood had registered too many people in the first division so allowed Pagewood to move a couple of people to make the teams even.

Clubs seemed to be upset and annoyed at the situation, however Queens Park explained that they didn't care anymore about the disruption they just feel bad for the girls who are unable to field a team.

Taleah mentioned to clubs that the FMC had originally refused the submission of this second team but Pagewood had appealed the decision and thus the FMC thought it best to put the question to the clubs. Queens Park asked what the FMC were going to do about it. Taleah explained that there is little the FMC can do so late in the season.

Julia asked how the competition was going despite this disruption. Clubs admitted that it was not too bad but UNSW are also not able to field teams in the holidays which is annoying.

4. EXTRA ROUNDS AAW1

Taleah explained to clubs that whilst the question about extra rounds had been done to death, with the change in format of the AAW1 competition, the question needed to be asked as to whether or not the teams would like to play extra games to take them up to 18 rounds. Clubs agreed not to play the extra rounds and just play out the season and then play the 3 week final series.

Coogee asked when they would be playing the winner of the AAW1. Taleah explained that the game will hopefully be played in the grand final weeks, pending on when the North West Womens competition finishes up.

5. GENERAL BUSINESS

5.1 Knock Out Cup

Coogee asked what happened to Maccabi with the Knock Out Cup as they had embraced it and had put together a mixed team. Taleah explained that they had forfeited late and had little control over it.

5.2 Gala Day

Taleah asked clubs what they thought about the Gala Day. Clubs explained that it wasn't a Gala Day as they didn't know about it, and that it needed to be prepared earlier.

Waverley suggested having it at a Central location with activities etc going on to give it the chance to raise funds.

Mascot mentioned that they had raised over \$550 towards it just by asking coaches and everyone for a gold coin donation.

Waverley suggested the association buy some pink socks and sell to clubs to make a profit towards the event.
