PRESIDENT'S REPORT

"United we stand or divided we fall"

This season has been a mix of many highs, lows and plenty in the middle, but one thing that remains consistent is that ESFA and the clubs associated are providing a good service so that our members can still take to the parks each weekend and play the beautiful game.

Before I get into the nitty gritty of this season, I want to say thank you to the Board, the Management Committees and Sub Committee's for another year of service. Your time and commitment is very much appreciated and without you giving up your valuable time, our competition would not be as successful as it is.

To Bill, Caroline, Richard, Chelsea and Jamie, thank you for all that do, your dedication to the running of this organisation is critical and often overlooked. Please note we are all very grateful that we have you supporting our beautiful game.

In the 2018 annual report I wrote about a strategy group that had been formed to help come up with key focuses for us to aim for in the 2019 season. As we prepared to work with GM and ESFA office to prepare the business plan we hit a number of speed bumps:

Our focuses were diverted to a legal matter which

saw the ESFA office having to battle against one of its own. Although the decision went in our favour, the fact of the matter is that no one really gained anything by it. It may have felt like a victory to some but for me it was gut wrenching to see our own clubs turning on one another.

Our second speed bump was at the start of January as we said farewell and good luck to our Juniors and Mini Roo's Coordinator Dale Quartey.

We saw our Juniors Director, Julia Chernoukha who was spear heading the strategy group and Director Richard Baldwin leave the Board due to personal circumstances. Both are people who are very committed at club level and do amazing work. We were very fortunate to have their services over the past two seasons.

With our strategy group impacted it was agreed by the Board to bring on an independent specialist to help us get back under way and support the process of building the business plan ready for the 2020 season.

Sessions one and two went very well and some great work came from it however lightning struck a third time and we said goodbye and farewell to our General Manager of 10 years, Mr Aaron Dibdin who has not moved too far away onto Football NSW as their Member Services Manager. I'd also like to take this time to also recognise Aaron and all that he did for the association and wish him well in his new role.

The strategy and business plan was placed on hold until we had a new Captain steering the ship as well as a new Juniors Coordinator (both MiniRoos and Juniors) on board. The recruitment for both roles was rigorous but in April we appointed Juniors Coordinator, Chelsea Brennan and in June we appointed the General Manager Bill Kostandas. Both of whom have made a considerable impact to our ESFA team.

The great news is that with the speed bumps under control it gave us the chance to continue what we started. Bill has literally picked up the pieces and run with the business plan, reorganising the workshops for you and the office, bringing on board My Club Doctor, an independent consultant who specialises in supporting and developing sporting organisations like ourselves.

However, despite the challenges, the ESFA team have ensured we kept the show on the road. Thankfully our Seniors Coordinator Caroline, juggled three competitions whilst we recruited our Juniors Coordinator, making sure all three comps got under way without any major hitches.

Our Grand Finals series over two venues went well and enjoyed by all, our Mini Roo's U6 & U7 gala days were yet again a great hit, as well as our Junior Grand Finals, kudos to our Juniors Coordinator for jumping in at the deep end and making this happen.

Believe or not, we saw 90% referee coverage for our matches this season and with the introduction of the sin bin in Mens Championship and Reserves divisions, we observed a 50% reduction in recorded abuse. However, being able to stamp this out to 100% is always the goal and we ask all clubs to focus on this moving forward.

Season 2019 was a productive period for our Technical Director, Jaime Gomez, achieving some important milestones for our pathways and development of football at ESFA. Three significant undertakings with Sydney FC, University of NSW and Matraville Sports High School were delivered, laying out a clear path for our local players to play at the highest level, development and holiday programs to cater for our local grassroots players and linking in with our local Talented Sports High School.

ESFA in conjunction with Sydney FC have also invested in a resource to develop school programs, through Alice Kriesler. Alice has been an integral part of ESFA Coaching the last 4 years and will now look at leading the connection between ESFA/Sydney FC and our local schools.

In closing, to the ESFA Board and Committees, thank you for volunteering your time and effort.

To Bill, Caroline, Chelsea, Jamie and Richard thank you for always being ready to go at a moment's notice when the going gets tough, thank you for making the season what it was and I look forward to working with you next season.

Again, I repeat what I said last season to our referees. It's by no means the easiest job to do, but you continue to turn up week in and week out ensuring a fair game can be played. Without a referee you have chaos. We all need to realise that we need to respect this crucial part of our beautiful game otherwise we will continue to struggle as an Association and never move it forward.

I would like to thank all those that are involved, to you, to your club and your board, the members that choose to play under ESFA. To the Sponsors, RTO''s, Coaches, Players and Volunteers who also play a vital part in keeping this association alive and thriving. May we stand united as one for the 2020 season.

GENERAL MANAGER'S REPORT

Only a few months into the role and it has been an enjoyable journey, more so in getting to know the stakeholders including Club representatives and Local Councils, the competition structures, grounds - the list is endless. The fact that it rains a lot more in Eastern Sydney than anywhere else in Sydney is something I can't get my head around!

Creating new and keeping key stakeholders has been a priority of mine. Relationships with Local Councils and Football NSW as well as the local media have been strengthened. Councils have a greater understanding of our sport, our needs and that ESFA and the Local Clubs play a major role in the Local Community. One of the biggest differences in this role is that ESFA has five Local Councils plus Centennial Parklands that provides grounds for football. In my previous role I only had to deal with one Council!

The ESFA Office is a pretty dynamic place to work in and there's always something happening with the staff having to prioritise tasks. A big difference for me at ESFA, is having staff on board assisting not only me, but more importantly providing services to give our members a great experience. In my previous role I had to rely on two office staff and volunteers. To Caroline Oakes-Ash, Jaime Gomez, Chelsea Brennan and Richard Beazley, thank you for your support and more importantly thank you for what you do for the Clubs and our members. They do care and always have the Members and Clubs in mind when making decisions. Thanks also to our Bookkeepers, Kilkran for providing accurate reporting and assisting with the daily financial management side of ESFA.

Caroline has been with ESFA in various roles for 9 seasons. In her current role as Competitions Coordinator - Seniors, she does a lot of work to ensure that the Seniors Competitions are administered smoothly. On top of that Caroline organises Judiciary Hearings and Disciplinary Matters, provides a weekly Communications piece, is the weekend contact for Clubs, mentors Club representatives, provides content for our website, puts together our Annual Report, provides updates on Facebook, helps other staff members; have I missed anything? The most impressive thing is that Eastern Suburbs football people, do really appreciate Caroline.

Chelsea Brennan came on board with ESFA early in this season. A Sports Management graduate, Chelsea had a steep learning curve, but she has come along well in her role as Competitions Coordinator - Juniors and MiniRoos. Chelsea also administers the ESFA Summer Football competitions. Chelsea is a good team player and I look forward to her continually developing her skills and working with our Clubs to provide a great experience for their members.

From my experience our Competitions are extremely professionally run, offer players great opportunities to participate in many competitions. Not many Associations provide a mid-week Cup



competition let alone the numerous ones ESFA provides. And then the Competitions Coordinators must deal with the rescheduling of fixtures due to wet weather.

Jaime Gomez is our Technical Director and has a great passion for player and coach development. We are fortunate at ESFA to have a Technical Director that is highly qualified and respected in his field.

Jaime has played the lead role for ESFA in the development and implementation of the player pathway. The ESFA SAP participants as well as the local community players now have a clear pathway (as I refer to later in this report).

Jaime also provides advice on competition structures with the pathway in mind. Leading up to the 2020 season he will be conducting coaching courses - from Grassroots to C Licence. Jaime has also assisted Clubs with visits and delivering coaching demonstrations. One of his strengths is his communication with stakeholders something that is imperative in his role as Technical Director. He is also a qualified lawyer so no doubt that helps with communication and sometimes required mediation skills!

Richard Beazley has been with ESFA for nearly two years as our Referees Coordinator. Referees are an integral part of our Football family and their efforts are truly appreciated. Richard came to us from FFA and is highly credentialed in Referee development and administration. He is currently working on development and strategies to recruit and retain referees. He will also ensure that several Referee courses, both at central and local club locations, will be run organised for 2020.

One of the deterrents for referees is abuse. The Sinbin for Men's Championship has certainly stemmed this. In an ideal world zero referee abuse would be fantastic. I know that it is not possible due to the emotional side that our sport provides, but players don't receive any near the level of abuse when they make a mistake or a decision that some feel is not right. Spectators as well need to be mindful that there is a Spectators Code of Behaviour. All I'll say on this matter is that people should treat others like they want to be treated!

The volunteers involved with our Clubs, with various ESFA committees and people who help in an unofficial capacity - our game would not survive without them. Sport would not survive. Saying thank you doesn't seem enough, but your work is truly appreciated by many. The same goes for coaches - they give up a lot of their time to ensure that our players learn new skills as well as participate in an organised team environment.

To the Board of Directors of ESFA, they bring a great skillset to the Association. They always make decisions in the best interest of the Members and the sport in the Eastern Suburbs. They are a deeply committed group of people who want to see people enjoying their Football and achieving their aspirations in the sport. Importantly they do listen to their members and are always looking at new initiatives to make the game better and more fulfilling for the ESFA Members. I sincerely thank them





for their advice, support and their hard work.

The pathway for our youngsters for 2020 has taken a giant leap forward. With the restructure of the NPL competition for 2020, our players now have a clear pathway to achieve their aspirations. With an MOU signed between UNSW FC NPL and ESFA, the ESFA SAP players now can continue their journey through having this choice to participate in youth and senior competitions at NPL level.

In stating that, the relationship between Sydney FC and ESFA has also grown. Not only is there a pathway for players, but also the two organisations have a shared resource. Alice Kriesler has just been appointed to the position of Fan Development Officer and her focus will be on school and community football, as well as Holiday Camps and Skills Training Program. Alice can also assist Clubs with major initiatives such as a development program to be run on a given day.

The Home of Football is also gaining a lot of traction. Discussions have taken place with potential locations being discussed, with one being very much in meeting our needs.

I would be remiss not to thank Aaron Dibdin. Aaron did a great job in his eight years as General Manager of ESFA. His handover to me was extremely thorough and professional. To this day he always makes himself available in answering my questions. He is a patient person! He is doing some great things already in his new role at Football NSW.

There are obviously initiatives and processes I want to do differently. The Board, the staff and I value the Members feedback. The workshops that have been conducted a proof to that testament.

In conclusion the best thing about Football is that there are so many touchpoints. Many people involved in our Football community get to experience the teamwork and social inclusion that a game of Football offers. That is priceless.

FINANCIAL REPORT

FOR THE YEAR ENDED 30 SEPTEMBER 2019

TREASURER'S REPORT

Dear Members,

Whilst sustaining its second deficit in a row, the 2019 deficit was \$23,922. This financial result was mainly attributed to the following:

- Employment Expenses: increase by \$45,822. This includes final payments to outgoing staff and a Long Service Leave provision added in;
- Telephone, Communications & Licence Fees: increase by \$19,248. This is attributed to a new phone system and a change/upgrade in software;
- Player Equipment Expense: increase by \$19,810. This is attributed to SAP apparel and equipment and Match Balls;
- Functions & Meetings Costs: increase by \$8,326. This is attributed to Westfield putting a charge on staff parking (\$5 per day per staff member).

However, there are significant decreases in expense items, which include Ground Hire, Maintenance and Grand Finals (\$19,424) and Postage, Printing & Stationery (\$13,777)

Overall the financial results have again delivered on the ESFA Board's aims of providing the services required by ESFA's member clubs effectively, delivering to our members excellent value for money, and ensuring that these are achieved in an environment of financial responsibility.

Season 2019 saw an increase in player registration numbers by 376. These were as follows:

In 2019 ESFA and the Board has continued to build on the sound platform that has been developed over the past eight years.

In an attempt to increase player numbers in the 14 to 18-year age bracket, the Board decided to decrease the ESFA fee component for those players.

From the above it shows that ESFA absorbed \$7,015.80 in registration fees.

Key 2019 Financial Highlights

- 1. ESFA returned a deficit of \$23,922 for the 2019 financial year. As explained earlier this was mainly attributed to the increase in employment expenses due to outgoing staff payments, a provision for long service leave added to this expense item, the purchase of a new phone system and upgrade of software, and staff being charged for parking.
- Revenues were up \$108,747; mainly attributed to the increase in player registration fees and player numbers. This was still considering ESFA decreasing its fee for the 14 to 18-year age brackets. However, in 2019, FFA did increase its National Registration Fee from \$12.60 to \$14.00 for juniors and \$25.00 to \$33.00. Football NSW did not increase its fees.
- 3. Expenditure was also up in the 2019 season by \$108,403, thus the Association recording a deficit. Expenditure (ex pass-throughs for referees and affiliation fees to Football NSW) was up in the 2019 season, contributing to the Association recording a deficit.

4. Net Assets at 30 September 2019 were \$261,457. This is 29% of our annual expenses (ex pass-throughs).



5. Receivables were up on expected levels at 30 September 2019 and mainly attributed to GST Receivables of \$21,074 and Trade Receivables of \$83,822. Payables were lower than expected levels at 30 September 2019 and mainly to a drop in Trade Creditors and nothing in Deferred Revenues. The Ground Development Fund is in excess of \$630,000 after eight years, providing a substantial sum to be applied to appropriate opportunities as they arise.


Underlying strong financial position

In 2019 the Board and management of ESFA has continued its policy of prudent financial management which began under the direction of the previous President and my predecessor Treasurer. The work of the Board in the past eight years has put ESFA in a sound financial position.

Whilst in 2019 we recorded a deficit, it is against a backdrop of a strong underlying financial position. The balance sheet shows that we have net assets of 29% of our annual expenditure minus passthroughs. Whilst we have posted a narrow deficit this year, our position still remains strong.



As can be seen below, in 2019 ESFA saw player numbers increase from the 2018 figures, but were marginally below the 2017 record high.



The increase in the number of registered players in 2019 is due to an increase across the three categories outlined below.

Note 1: Statement of Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act New South Wales. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax under Section 50-45 of the Income Tax Assessment Act 1997.

b) Inventories

Inventories are measured at the lower of cost and net realisable value.

c) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

d) Impairment of Assets

At each reporting date, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

e) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

Note 1: Statement of Accounting Policies (continued)

f) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

g) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less.

h) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

i) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

j) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

k) New accounting standards for application in this reporting period

AASB 16: Leases (applicable to annual reporting periods commencing on or after 1 January 2019).

The main change introduced by the new standard is as follows: - recognition of a right-of-use asset and liability for all leases (excluding shortterm leases with less than 12 months of tenure and leases relating to low- value assets). Since the currrent lease has a term of one (1) year, the directors have assessed that it is not applicable in these circumstances.



TECHNICAL DEVELOPMENT AND COACHING AND TECHNICAL DIRECTOR'S REPORT

Throughout the 2019 Season, the ESFA Technical Department delivered various programs and initiatives that will see our Coach Education, community engagement and football pathway for both boys and girls grow in the coming season.

Building from 2018, ESFA worked with our member clubs to deliver coach education in two formats, being formal coach education through centralised coaching courses, and community workshops which were delivered in-house at our local clubs offering volunteer coaches the opportunity to receive guidance and a sample of formal coach education. These programs were well received by our clubs and coaches, which assisted coaches to grasp some of the key concepts of coaching for their specific age groups and an understanding of the Football Federation Australia (FFA) National Curriculum.

For the season ahead, we will be looking to implement more club based courses and game leader workshop to continue the work from previous years and to reinforce key concepts to ensure we are creating a safe, fun and learning environment for our young footballers. Off the field, the Technical Department was also busy forging partnerships with key organisations that will allow us to grow as an association and give all our footballers the best opportunities within the eastern suburbs.

Three key partnerships were finalised between ESFA, Sydney FC, University of NSW FC and Matraville Sports High by the signing of Memorandum of Understanding between the organisations. All are significant and equally important relationships, that will help assist our entire football community.

The partnership between Sydney FC will deliver various programs. We welcomed a familiar face through Alice Kriesler, who will develop and drive the following initiatives. Alice will be based in the ESFA office and will deliver the following programs: School Holiday programs, in-house School programs and Skill Training programs.





All programs will be co-branded and will be run by both Sydney FC and ESFA experienced coaches.

ESFA, in conjunction with University of NSW FC, will expand its youth football programs through a licence to participate in the Football NSW NPL 2 Youth competition for boys aged between U13 and U16. For several years, ESFA had felt the need to expand its program beyond the Skills Acquisition Program (U9-U12) to allow the players of the Eastern Suburbs an opportunity to participate in the next tier of football. The teams will play under a combined banner being, UNSW Eastern Suburbs FC and club colours will combine both organisations to truly reflect its roots. ESFA will be responsible for the implementation and management of the Youth Program including appointment of fully gualified coaches and selection of players. The partnership will align with our SAP and give local club players an opportunity to progress their football within a club they can call their own.

The final significant MOU has been signed with Matraville Sports High School. This is an important part of our community and ESFA will support the School in promoting the Talented Sports Pathway as well as assist them where necessary to deliver the program. The partnership also coincides with Sydney FC as it is one of their Academy Schools and this will allow players the opportunity to gain an education and continue their football development. In turn, the connection between the School and UNSW FC Youth Program will mean players will have a unified program to ensure both education and football are aligned.

As per previous years, football across our parks has improved again and the standard of play is increasing each year. This is credit to all clubs and their coaches for their approach in providing players an enjoyable and learning environment. Through coach education and coaching resources, players at all levels are now experiencing better structured practices. Girls football continues on the rise and it is great to see the amount of young girls joining clubs and creating friendships. ESFA is committed to providing young girls the opportunity to enjoy the game and engage them so that they continue playing. Similar in the boys space, with the level of play increasing and the demand for programs within our area.

The ESFA Skills Acquisition Program (SAP) for both Mixed and Girls once again had a successful year under the guidance of our Program Head Coach, Joe Holt. Players developed throughout the year and received a football education that would hopefully put them in a good position to progress to the highest level for years to come.

A special mention to those players who were selected to represent our region during Football NSW State Titles and also so Sandy Zaverdinos from our SAP U12 who was selected to join the Sydney FC Academy under 13s for 2020 season. This is a credit to our coaching staff along with our Goal Keeper Coach Trinity Allen, who has worked with Sandy for several years.

Through our partnership now with Sydney FC, we are recognised as 'The' SAP licence in the Eastern Suburbs and will see our teams in 2020 have the Sydney FC badge on our playing jerseys as well as opportunities to be scouted and work with the Academy.

Finally, thank you to the ESFA staff and Board, in particular Dr. Andrew Field, for their support and



commitment to getting the several MOUs over the line and always supporting the drive to deliver quality programs for our footballers. Exciting and big things to come in 2020.

JUNIORS FOOTBALL DIRECTOR

Junior numbers were static this year. In fact, they have been relatively static for the last 8 years. However, where some age groups were strong, our 14 and 15 boys particularly, the issues we deal with on player depth came into sharp focus, when we only had 5 teams register for the 16s competition. Whilst this may be an anomaly, it is concerning that we had such a small participation rate. This was the second cohort to transfer to Sunday football at 15 and whilst the strong numbers in 15s this year do not indicate a trend, it should be monitored. Another disconcerting number, is that we only retained 64% of our 12s in 2018 to 13s in 2019. The 12 to 13 transition historically is our biggest loss, this year was no exception.

Having consistent times is one standard, we think consistent divisional makeups should be another, with Championship divisions having 8 teams where possible.

Thank you to all those volunteers who dedicate their time and energy to promoting this wonderful game. Juniors is an area where we have a special issue on player recruitment due to the plethora of private schools in the area who play sport on the weekend. It is important that our clubs and ESFA work together to try and increase our numbers to ensure we have a strong and vibrant competition.

MINIROOS FOOTBALL

Some key statistics:

- 253 teams U8 U12 (non-competitive)
- 23 teams U6 U7
- 13 scheduled rounds with four extra opt-in rounds (school holidays)

One of the hiccups we encountered this year was the scheduling of school holiday rounds. We had feedback from clubs that many teams did not want to, or could not participate during the school holidays. This led to a difficult draw creation that could not be posted online (due to the draw having to be created in excel). For 2020, we will have to find a new way to tackle this issue as it is not sustainable or efficient.

Regrading was another big issue we found this year, with many teams not happy in the division they were put in, although this was the division that was nominated by their club. We tried to accommodate most regrades, but this caused more chaos than good with too many unnecessary byes being created. 2020 will have only one regrade for MiniRoos and teams will only be able to move if there is a team who can swap with them to eliminate the possibility of excessive byes.

As with the past few seasons, we saw too many forfeits against Sunday teams. This was very disappointing for all and I hope next year Sunday teams will get to play all games that are scheduled.

On a lighter note, our Gala Days were a huge success with our final Gala Day seeing 108 U6 and U7 teams participating! This is a slight increase on our numbers last year which is good to see.

Set timeslots continue to be a big success with timeslots now also for girls matches on Sundays. This allowed for greater planning although differing timeslots depending on location is still an issue for the girls.

All in all, we had another successful season. We experienced a bit of disruption due to late team entries, withdrawals, few mismatched teams in certain divisions and wet weather. For the most part, all were handled efficiently. Unfortunately, some teams had to play inevitable double header games due to the significant rain fall received during the season.

WOMEN'S FOOTBALL

On a large scale, we watched the Women's World Cup which has been described as the most important in history, on changing attitudes and the drive for equality in the women's game.

Although the new format brought upon some uncertainty at the start, our clubs expressed positive feedback later on and during the season, enjoying the added fixtures. COMPETITION COORDINATOR REPORT

2019 was a preseason, season and post season of challenges, chapters, change and changeovers!

With the departure of our MiniRoos Coordinator in January 2019 the quest to add a new employee to ESFA and change the role to Junior Football Coordinator, embracing the MiniRoos and Juniors Competition portfolios, commenced.

While this search took a significant amount of time to ensure the best candidate was employed, the consequence of same, was commencing 2019 balancing all three portfolios, to ensure the 2019 season commenced on schedule for every registered player.

Fortunately, our new Junior Football Coordinator was employed the day before season start, ensuring priority could once again be given to the Senior Competition, whilst mentoring our new Coordinator, Chelsea.

However, in April our then General Manager Aaron Dibdin, announced his resignation to embark on a new role with Football NSW. The transition period between then and his replacement on 3rd June 2019, meant some more, albeit limited through experience, interruption at ESFA headquarters.

Combined with a new registration system which appeared to not live up to its creator's promise and ensure a whole new line of frustrated registrars, the inability to print player card ID was a paramount disappointment and a creation of lack of player ID checks prior to every match. Whilst a player PDF sheet could be produced by the new system, it soon became obvious that teams were less inclined to check ID regardless of the fact it is a clear requirement of ESFA Competition Rules. We are currently working with Play Football and Football NSW, along with every other affected party throughout the State, to rectify the current player ID production.

The Louise Mazzaroli Cup was held in February 2019 with the momentum caused by this, optimistically looking to an O35 Women's Competition in 2019. This is still to come to fruition after a number of attempts to



bring back this competition, not seen since the early 2000's. To move forward with Women's football, we need to provide the correct and best competition which will require the persistence of all within the women's football community.

Senior competition football never really starts on the first weekend of the season. Preseason sanctioning of trial games went at a rapid pace from November 2018 through to April 2019! More friendlies played than in any previous preseason, placing huge burdens on the constant sourcing of grounds for our Clubs, once again proving the need for a "home of football" and football fields to be available outside of winter.

With Grand Finals held across one weekend in September, there was a great atmosphere at Heffron over the 3 parks used and as equally a loud one at Hensley.

MEN'S FOOTBALL – FRIDAY NIGHT COMPETITION

Our Friday night O35 Championship competition grew in 2019. While Barnstoneworth hoped to enter a team, there was a last-minute hurdle and with the nomination received from Lokomotiv Cove, the O35 competition became 7 teams up from a 6-team competition in 2018. Following on from 2018, there appeared to be a change in player behaviour resulting in a far less judiciary and far more football. With the State Cup offering some draw adjustments, it was pleasing to witness Dunbar move through the Football NSW State Cup final as well as being Premiers and Champions for 2019. We hope more clubs embrace the Friday night football in the O35 Championship with the goal to have an 8-team competition for 2020. The gentlemen of this competition were able to play 21 rounds of football in the season!

MEN'S FOOTBALL - SATURDAY COMPETI-TION

Prior to the commencement of Season and as early as February, Men's Clubs were advised of the Promotion/Relegation system to be brought in at the end of 2019 for the 2020 season for the AAM Championship competition. AAM Championship Clubs met and worked through a suitable proposal which would achieve this goal and allow for Clubs to enter from lower Divisions. These meetings were chaired by the newly formed Men's Championship Committee and both Leighton Robins and James Whiteford showed their commitment to task working closely with myself and our Men's Chair Adam Gwynne. However, discussions with Clubs, Board and Committee post season and after addressing concerns from Clubs, has enabled an 11-team competition for 2020 in AAM Championship, in its 2019 form, albeit to be renamed Premier League.

However, before all the post season, back in 2019 preseason, the Clubs voted the competition for 2019 remain as a ten-team competition thus negating the return of Dunbar Rovers FC to the competition after their withdrawal after season commencement in 2018. This did though allow Dunbar to enter at the AAM1 stage to work toward the promotion stage of the new adoption of 2020 ESFA Premier League Promotion and Relegation. However, in March 2019 Maroubra United advised they would be unable to field an AAM Championship squad and accordingly the ESFA Board signified their agreeance in allowing Dunbar Rovers FC to return to the AAM Championship competition as per Clubs agreement to the ten-team competition.

The somewhat contentious head to head rule passed by clubs prior to being ratified and adopted by the ESFA Board as part of the 2019 Competition Rules, ensured the last few weeks of competition became one of the tightest battles in Men's Championship history. With Coogee United seeking back to back premierships after becoming Premiers, Champions and Champions of Champions in 2018, with points being equal at the end of the season and Coogee ahead by goal difference of 1, the head to head rule crowned Dunbar Rovers as Champions. The ESFA Men's Cup was won by Coogee United as well as the Grand Final and Dunbar Rovers represented ESFA in the Champion of Champions making it through to the Quarter Finals.

Phoenix were crowned Premiers of Reserve Grade in 2019 and reversing the luck of the Irish from the previous season, capped this off as Champions for 2019!

Randwick City FC AAM Championship reached the finals of the Football NSW Bill Cullinan Cup (State Cup) and whilst did not come away victorious, should be pleased with their campaign, proving once again the standard of Men's football in the Eastern Suburbs.

The ESFA Men's Cup final between Phoenix and Coogee Men's Championship teams was history making, when Coogee United were victorious winning their third consecutive Cup! A feat not achieved prior and surpassing Maroubra United's two consecutive Cup wins in 2015 and 2016.

Queens Park Rangers became premiers of the AAM1 (Sat) competition after a convincing 2019 season, which would have resulted in promotion to Premier League for 2020 prior to further discussions. We hope they work toward entering Premier League in 2021.

Redfern Raiders AAM3 (Sat) enjoyed a highly successful season as undefeated Premiers and 2019 Champions!

Our other Saturday Men's divisions ran well especially after a regrade in Division 3. Division 5 Premiers and Champions were the only team this season to win the triple, with the ESFA Men's Trophy added to their portfolio.

The ESFA Men's Shield Final was also decided between two Saturday Competition sides, with Sydney CBD winning their first ESFA trophy since joining the Association in 2016 having grown their Club since their inaugural season.

The Men's Saturday Competition is one of strength and increasing number. A change created in 2013 as one Saturday Division became 4 in 2019. The change ultimately created the betterment and advancement of Men's football.

MEN'S FOOTBALL – SUNDAY COMPETITION

Our collective goal should be primarily to have 10 team competitions in the highest Sunday Men's Divisions. We cannot continue with the mentality of not accepting loss. It's football. Win, lose or draw. We certainly understand the laws of attraction in recruitment and retention by our Clubs however, to ensure our divisions are created for the advance of the game of football, may mean that teams advance in division, to create viable competitions and not a continuation of the same scenarios. Grading needs to be a strong focus for 2020 to ensure the growth and strength of Sunday Men's Football.

ESFA AAM1 Division was a prime example. By grading teams into this Division, we were able to offer an 8-team competition for 2019. Our goal should be to increase this to 10 teams in 2020. Whilst Coogee United dominated this competition and became undefeated Premiers by 16 points, South East Eagles were crowned Champions after an epic Grand Final of football decided on penalty shootout. When you hear the crowd at Hensley from the car park of Heffron, it means that's one heck of a display of football.

Certainly, there were challenges for those teams in the lower level of the ladder however this may be said of all divisions in not only ESFA but all amateur and professional leagues.

From AAM2 through to AAM8, with the minimum of regrading. However, teams and Clubs that have dominated the divisions should be aware that promotion to a higher grade will occur. To ensure grading is as fair to all Clubs as possible in 2020, ESFA will audit registered player names against 2019 to alleviate the continual scenario of "our best players left", prior to grading and throughout the season. To triumph in a division by double digit points, should leave no negotiation as to 2020 placement. This may mean an earlier date to be set for registration purposes.

Our aim should be to have competitive divisions in the higher grades as well as the lower grades. Continually winning one division and returning to that division and winning it again, should not be deemed as acceptable to the wider football community. Embrace a challenge and work your way up. Some clubs have managed this exceptionally. UNSW AAM2 became 2019 premiers and have challenged themselves each season by accepting grading in a higher division.

O35 Division 2 grew in its strength albeit not in number in 2019. Coogee United once again dominated this division with teams finishing in 1st and 2nd place on the table. The B team became premiers and champions and won the inaugural Masters Cup, a competition which allowed them extra fixtures as well as an opportunity to play the top two O45 Championship teams. As a 6-team competition is viable, once again to increase this to 8 teams by the encouragement of AA teams entering past the age of 35, this competition will remain a successful innovation.

O45 Championship was full of its own complications. Success should not be punished, nor should it be ignored. It was up to the FMC to consider several options for the competition for 2019. The final makeup of teams playing each other once, before splitting for the last rounds plus the introduction of the Men's Masters Cup and Masters Trophy providing all teams with further fixtures. Most of the feedback has been positive however, with anything new, pleasing 100% of the people 100% of the time is a task that one relishes but may not always achieve!

We acknowledge the success of Pagewood O45A in becoming Championship Premiers and Champions. Pagewood also progressed as far as the Champion of Champions Semi Final. It should be noted that Pagewood were the only team to progress past the Quarter Final stage. A feat which should not be taken lightly.

We look to 2020 in the hope of securing an 055 Men's Competition, possibly in 9 v 9 form, to enable our gentlemen not quite ready for walking football, to continue their love of the game on a far less competitive platform.

WOMEN'S FOOTBALL

Once again ESFA was able to offer 5 divisions of women's football.

However, this did come at a cost. The AAW Championship which should be the epitome of the Women's Competition and the flag ship of the Association's success in Women's Football, had five teams. The five teams played each other 5 times and had 4 byes in the mix. Fortunately, there were State Cup fixtures to play as well to ensure change of opposition, as well as the ESFA Cup.

2020 ESFA will introduce a 10 team Premier

League competition for Women (replacing the AAW Championship) as agreed at the preseason Women's Council Meeting. All divisions will contain 10 teams and 4 divisions will be therefore offered. This will be the kickoff to move the Women's competition forward at all levels. Our reputation of fielding quality female footballers should not suffer due to the fear of change. Nigel Singh and a group of representatives from Clubs met during the year, to contribute ideas and support of the top Women's grade along with the Women's Chair Sarah Ferris, and myself. ESFA as a community should not fear short term pain for long term gain. There needs to be a commitment to a 3-5 year plan to ensure that female players see ESFA as the Association to join.

Sometimes it can be said that teams become a victim of their own success with both Coogee and Dunbar dominating the competition again which often creates the "hesitance" for clubs to correctly recruit for the highest grades or even be willing to be placed into the highest grade. With Dunbar once again taking premiership rights for 2019 it is an interesting statistic that the only team to beat Dunbar once in the entire season, was Coogee. Though football can be a funny game. With Dunbar and Coogee knocked out of the Grand Final it was up to Sydney Uni and Waverley Old Boys to become Champions for 2019 with Sydney Uni taking the trophy home, proving hesitance is not an excuse.

Coogee United reached the semi final of the Football NSW State Cup which was an excellent result for ESFA women's football.

Status quo is remaining in the past and present and hoping no one becomes disgruntled and we just play in a unicorn and rainbow existence like our previous childhoods! For the sake of our Clubs in ESFA running women's football, this status quo needs to change because disgruntlement and fantasy, is the killer of community park football.

AAW2 commenced as a 10-team competition however a regrade of Sydney Uni brought the competition to 9 teams. The Top 2 teams proved their worth to move into Women's Premier League with Dunbar Rovers taking out the Premiership and Randwick City becoming Champions. With only 3 points separating 1st and 2nd place, the 25 better goal difference by the 2nd place getters, has earned them a promotion for 2020 into Women's Premier League. Maroubra United proved their consistency and will move back to the Women's top grade and test themselves further.

AAW3 was one of the best competitions in ESFA in 2019. With the top 4 teams on 36, 35, 35 and 34 points with 5th and 6th on 32 and 27 points. To have a competition of that standard and quality is exactly what should occur in every division. Coogee United took the Premiers title and after a hard fought grand final, the team equal on goal difference, Sydney Uni took out the Champions title. We look towards our clubs promoting these women and encouraging them to continue their football paths and testing themselves on a higher platform. Lokomotiv Cove completed the season on 35 points and 3rd place, won their first ESFA Women's Trophy knockout competition final against League Premiers, Coogee. 2nd place getters Sydney Uni Gold became 2019 Champions. This is testament to the competitiveness of the League.

AAW4 almost replicated the success of the AAW3 competition. Lions FC promoted from AAW5 in 2019 became premiers and look forward to the next jump in their ESFA football career. This year the AAW4 top 4 teams were on 43, 33, 30, and 30 points with 5th, 6th and 7th, 24, 22, 19. Following the regrading of Heffron Hawks AAW4 into AAW3, this division finished with 9 teams.

AAW5 was made up of 8 teams for 2019. With Maroubra United given permission to play in the AAW5 play off rounds, albeit on the provision of not qualifying for finals, the season was one of triumph for Maccabi who finished 17 points ahead of their opposition becoming 2019 premiers, clearly placing them in AAW4 for 2020. It was pleasing to see Coogee United introduce an AAW5 team made up of beginners to football. This is the clarity required when grading teams to allow ESFA to grade correctly.

We hope and trust in our Clubs, grading in 2020 will be in accordance to competition, skill and experience, with ESFA to run a four-division competition consisting of 10 teams per division, for Senior Women as discussed at our preseason Council meeting.

The senior competition remained steady in number in 2019 with a slight increase of 185 players to the ESFA community. To maintain these numbers requires a lot of hard work from our overworked volunteers and we salute all our Clubs and their volunteers in ensuring football is played throughout the entire season. Volunteers are not just committee members, they may be the coach or the manager or that spectator who turns up every weekend and assists. There are many backbones to the Association, and it is important that volunteers are recognised and never taken for granted by their Clubs or within ESFA.

Judiciary was no worse in 2019 as in 2018. In AAM Championship with the introduction of the sin bin, there was a clear decrease in referee abuse. However, this was still too prevalent in all other senior competitions. It is imperative that Clubs consider repeat offenders when registering players.

The 2020 Competition Rules will introduce the sin bin rule to all AA Men Competitions.

It was also concerning to note an increase in coaches/managers appearing before the Judiciary for charges of match official abuse. A coach is a leader and must lead by example. Tougher penalties will come in for coaches and tougher sanctions concerning their role at both training and game. A great coach once said: "attitudes are contagious. Are yours worth catching?".

DISCIPLINARY REPORT

2019 proved to be another challenging year for the administration of the Judiciary.

Nearly all aspects of player conduct, and discipline deteriorated compared to 2018. Players were issued with red cards at an average of 1 every 7 games (7.3 in 2018). In addition, there were 38 Citations and 10 Hearing requests (average of 2 per week).

These statistics obviously have a flow on effect, challenging referee retention and recruitment and also challenging the number of volunteers needed to hear Citations and Hearings.

ESFA is grateful for the contributions of Simon Phillips, John Harris, John Clayton, Ron Ogilvie, Jaleh Shafie, Amy Singh, John Sweeney, Roy Belcher. Volunteers are always welcomed and to rely on the same with the number of hearings throughout the season is problematic for administration and all.

Contact the General Manager if willing to assist with the Judiciary Committee.

The only ray of hope in the deteriorating statistics, is the 2019 Mens Championship trialed a sin bin rule for dissent. A player receives a yellow card plus a 10-minute sin bin for dissent. All stake holders and statistics (40 percent reduction) support the introduction of this in all senior Divisions in 2020.

Thank you to Caroline for her continual commitment to the Disciplinary process.

Hoping for better news to report at the conclusion of the 2020 season.

REFEREES COORDINATOR'S REPORT

2019 was a successful season for the referees in the Eastern Suburbs.



Level 4 Referee training courses were held in February and March with a total of 52 new junior (U18) and 14 older referees gaining their qualifications. In addition, two Level 3 Referee courses were conducted with 17 referees attending and a Level 2 (Theory) Referee course being run with 13 attending.

Two pre-season seminars were held on Sunday 17 March at the Kensington Community Centre. One seminar was dedicated to returning referees (51 attendees) with the other seminar specifically targeted at new referees (40 attendees). These were conducted by branch coach Jack Bell and myself and included technical sessions including changes to the Laws, managing the difference between dissent and foul/ abusive language, temporary dismissals and game management. There were also technical sessions held at the same venue on the first Monday of each month between May and August.

The TBA process within our appointment system was conducted twice per week this season which assisted in covering additional matches. Finalising this process by 12 noon Friday allowed Clubs time to source their own referee if needed with a degree of certainty. We are looking at how we can improve this in 2020.

Timeslots for junior matches assisted us in maximising the coverage of these matches, quite often with a full team of three officials. The scheduling of senior matches through game amendments and time requests past the cut off time, should be the exception not the norm, past the season draw publication. For example, having two matches kicking off at 9.00am and then the next two senior matches starting at 3.00pm means four referees would be needed to cover these four matches whereas two referees could cover all four matches.

Appointments are done on a weekly basis starting at 9.00am Tuesdays which is the deadline for requests for match amendments. Changes to time and/or venues after this time often means teams lose their appointed referee(s).

The implementation of temporary dismissals for dissent in both grades of the Men's Championship competition saw 51 players spend 10 minutes off the field compared to 92 cautions issued for dissent in the same competitions in 2018 - a reduction of 45%. Consideration is being given to extending the competitions in which temporary dismissals are to be used.

Unfortunately, we lost several of our best young referees between the 2018 and 2019 with many deciding not to continue refereeing as a result of the behaviour of players, coaches or parents during last season. Even during this season, we lost a number of referees due to this type of behaviour. We would not tolerate an adult yelling at a young person while at the local shots who they did not know. So why is the same behaviour acceptable when a any person puts on a referee uniform? The referees who officiated in the ESFA Grand Finals did so in a professional manner and supported each other during the matches at Hensley Athletic Field and Heffron Park. Thank you for all the referees who assisted with the Grand Finals and supporting ESFA staff on the day. Thank You

The technical group that we setup last season continued in 2019 and provided some coaching support to members. This group included our branch coach Jack Bell, Arthur Kringas and Anthony Kabbout. My sincere thanks to those three who assisted me during the season in so many ways.

To the various board members thank you for the time that you, as volunteers, put into this sport.

A special thank you to my fellow ESFA staff

members Bill, Caroline, Jaime and Chelsea, together with the departed Aaron, for the support and guidance through all-things ESFA.

Finally, a sincere thank you to the ESFA referees who officiated in matches during the 2019 season. Our jobs are never easy and your commitment both on and off the field usually goes unnoticed except by your colleagues. For those who may be retiring or moving away I thank you for your service.

2019 was an interesting and rewarding year and I am sure we will continue to work together as a football

community to improve both the competition and refereeing standards here in the Eastern Suburbs.






PARTICIPATION BY LEAGUE COUNCIL 2019




PARTICIPATION BY GENDER




PARTICIPATION BY AGE CATEGORY




PARTICIPATION BY SEASON



PLAYER STATISTICS MALE VS FEMALE





