President's Message

I would firstly like to thank Alan Chow for all the help he has given the Association (you the members) over the last 3 years. He joined the Board at an indifferent time for the Association, to say the least! He leaves with a job well done! Far more than expected! It seems so little, with so much having been done, just to say 'Thank you Alan' but you know how sincere that it is, mate!

Outside of the eastern suburbs, the Association has a very large role to play within the grass roots of the New South Wales football fraternity and in this years message, I would like to open up your thoughts to that world.

The Association is one of 17 organisations and associations within the Sydney basin. This is called the Sydney Branch. There are 3 other Branches, Southern, Western and Riverina, making 32 organisations and associations covering New South Wales.

The Branch roles are similar but the main difference is that the Country Branches run competitions within their areas, yet, Sydney Branch does not. The Sydney Branch is going through a transitional period and next year, it is likely that it will become a Standing Committee to the Board of Soccer NSW, as later, all Braches will become.

Therefore the main aim of the Sydney Branch is for it to become a lobby group for it's members and provided all the members get involved, it would be an entity with a lot of clout in the football negotiating stakes! The Sydney Branch is funded mostly from Soccer NSW and has its own executive. It has 3 seats on the Council of Associations Executive compared to 1 from each of the other Branch's.

The Sydney Branch is also your next port of call for all judiciary matters. After the initial hearing at ESSFA level and then an appeal to our appeals tribunal, you can, through our office, appeal to the Branch. If further decisions were required, you would then appeal, through our office, to Soccer NSW, FFA, Asia Confederation and then to FIFA.

I've mentioned Soccer NSW a few times and as you probably can tell by the name, that this is the state governing body for all football matters. Soccer NSW has it's own Constitution and By-laws and is lead by a Board made up of a President, VP and 8 Directors. Six of these Directors are elected by members of the Council of Clubs, representing all the State League Clubs, the Council of Associations, representing all those Associations and organisations within the Branches mentioned earlier and various Standing Committees. The other 2 Directors are appointed to the Board by the elected members.

The President and VP are also elected by the same group of members. That will happen for the first time since unification in December 2006. You will read, listen and see all about it in the various news items I'm sure! The major reason you will, is because of the importance of the position of President. Soccer NSW governs some 280,000 players and is the largest sporting organisation within any state! It is also the largest participated sport in the country. With our some 6,500 playing members we are also the largest sporting organisation within

the eastern suburbs.

Amongst other duties, of which I'll leave for another day, Soccer NSW also runs the competitions within the Sydney basin, like the Champion of Champions, the State Titles, Youth League and the Metropolitan League for our budding eleven and twelve year olds and at this point, I would like to congratulate Andrew Field for coaching the best eleven year old boys in all of the Sydney Associations by winning the Metropolitan League . Well done boys!

Through the hard work of the Board, we are now recognised by the state football fraternity as a very progressive organisation with some very innovative ideas, like having pathways for our kids with our MOU with both Sydney University and Sydney Olympic and our MOU with the Eastern Suburbs Soccer Referees Association, just to name a few. Board members have been and are still, actively involved with various positions within the fraternity, that give the impression that the Association is interested in the success of the game state wide.

This, of course is true. A successful state is very important to us all, not just for the elite footballers but they control our insurance cover, a large part of our fees and they have access to both State and Federal Government bodies of which we get funding from. Any help in this area is always most welcomed!

A good State body is also important for the stability of the sport, as we are finding out now, in light of the new Constitution that the FFA require us to implement! This new document came about from the Crawford report of which the Federal Government is using as a blue print for all football management within the country and because all members of the State are against the changing of our Constitution, as of November 2006 Soccer NSW is not a member of the FFA. There is more to come of this from the discussions still taking place between Soccer NSW and the FFA but one thing is very clear and that is the fact that the FFA did not know how well the state body is supported by ALL parties from within!

I hope that has enlighten you somewhat of where our Association sits within the state and why it is important for us to be actively involved with our higher bodies. There are some more interesting opportunities for us to take another leading and active role over the next twelve months and I will endeavour to keep you informed.

Please take care over the holidays and I look forward to meeting you all again in 2007.

This high standard is reinforced with Ron Hoenig and George Lundy at the Appeals level. Corporate Vice President's Message

The member's support for our amended Constitution at the 2005 AGM allowing the restructure of the administration and management of football in the Eastern Suburbs has proven very effective in Season 2006. The Board have confidently relied upon Football Vice President Sean Fenton's leadership of the Operations arm of our business, driven by Operations Manager Liz Terry and assisted by Mel Waters.

The sound functioning of our Operations division and Football Management Committee has allowed the Board time to concentrate on our corporate governance needs to move forward and drive significant improvements in the performance of the Association. This progress would not have been possible without the sound management of our total business by CEO Mark Louis.

The Board have achieved great strides in repositioning our Association within the Football Family. We are raising the profile of our Association at Soccer NSW Council of Associations level through the Executive role played there by our President Roy Belcher, who has had a key role in developing the Soccer NSW Constitution. Earlier this year, I was appointed as Chair of the Soccer NSW General Purposes Tribunal. We will continue to develop networks within Soccer NSW to advantage our members.

We will move forward now to develop our Business Plan to fund and deliver planned improvements to our service delivery.

Working together with our CEO, I have assisted in the development of an Employment Manual, Employment Contracts and Position Descriptions for our staff. With our work on the Memorandum of Understanding, we have moved to position ourselves into a "customer/ service provider" relationship with local Referees. We are also reviewing policies and processes that govern our services to our members.

This Board is keenly aware that our most important product is providing football experiences for as many men and women, boys and girls that we possibly can within this small and unique geographical area of Sydney. So much of the credit for the Association's growth success in 2006 and our plans for 2007 rest largely with our member clubs and their volunteer base, players, parents and regular fans.

The 2006 AGM ends an "era" within the Board. Our Vice President Alan Chow is retiring at this election to concentrate on his club commitments. Alan's is a voice of calm reason, sensible compromise, and unquestionable dedication to the beautiful game. Chief Executive Officer's Report

We are seeing times of progress in the world game and it is an exciting time to be involved. The transformation taking place in the Eastern Suburbs is typical of the great work being done across the country. Following the AGM in 2005 the operational and management structure of ESSFA was subject to immediate change. These essential changes and improvements were implemented to ensure the continued and effective running of the organisation.

The Associations restructure has brought some vital, yet necessary, staff and management changes. The most notable introduction was that of the Football Management Committee who manage all ESSFA competitions. Well done to the Football Management Committee of Sean Fenton (Chair), Wally Holzer, Andrew Cartwright, Simon Preston, George Lundy and David Lewis.

Financially, ESSFA had another good year generating a net surplus of \$80,654.16 compared to last years \$43,375.95, bringing the association from an accumulated deficit position in 2005 of \$2,565.86 to an accumulated surplus in 2006 of \$78,088.30.

While the surplus is significant, other board achievements include paying back the Soccer NSW debt in full and reinstalling member bonds, which disappeared at the time of previous executive committee's, back into the Balance sheet. The financial success over the past two years will enable the association to start planning ahead.

The association developed two new events into the yearly calendar in the Eastern Suburbs Beach Soccer Tournament and the Super Summer Sixes. Both of these events, which are in the very early stages, have enabled the association to gain some revenue outside of normal activities

The Board endorsed a Strategic Plan which is the Association's first planning document setting out the strategic intentions of a new and invigorated organisation. The strategic plan represents the valuable input from our member clubs and from the Directors. I wish to thank all those people who have given their time and shared their practical experience and insights and I invite all supporters of our great game to adopt this plan as your own and collectively work towards achieving the outcomes.

The Board has also endorsed a Marketing Plan for the association which will enable the association to develop a position for Eastern Suburbs Football in the market place and drive the brand and our position through a streamlined approach of internal and external communication.

The Board have been working hard with Sydney Olympic FC and Sydney University FC in developing elite pathways for players within the Eastern Suburbs. There is now a clear pathway for the development of football players at all levels of ability. I would like to acknowledge the massive amount of work undertaken by Con Tsattalios, Abbas Saad, Tom Adam and the Youth League Panel of James Kospetas, Simon Phillips, Jim Zammitt, Ron Hoenig, Sean Fenton and George Lundy in making this possible.

Chief Executive Officer's Report

A very special congratulations to Dr Andrew Field, Andrew Demetriou and the team who claimed the Under 11 Boys Metropolitan League competition, the first time an Eastern Suburbs side has achieved such success.

The Association now has developed relationships with all 6 local councils and the Centennial Parks Trust which will enable us to negotiate on a stronger footing for the development of grounds we have access to and to increase the number of grounds in order to keep up with the demand. The Board and staff will continue to challenge the councils in respect to grounds.

The Staff at ESSFA continue to play an important role in providing quality service to our membership and I would like to express my sincere thanks to Operations Manager Liz Terry and Administration Assistant Mel Waters. The Football Management Committee was very well supported by Liz Terry with the day-to-day administration of all competitions. A special thanks must go to Liz who has worked hard throughout the year to ensure that all competitions were conducted professionally and successfully, considering the introduction of a new Competition Management System and the trying weather conditions.

It remains important that the constant efforts of the Board of Directors are acknowledged. Personally I would like to acknowledge and thank the President Roy Belcher and the Board for their confidence and encouragement during this challenging year. I would also like to personally acknowledge our out-going Vice President, Alan Chow, for his guidance and commitment to the association.

I am looking forward to a new year of football and continuing to provide the Board and members with service and support.

The Association had a good financial year. Our operating surplus, that is the income we made less the expenses that we paid during the year, was \$80,654.16. This brings the Association from an accumulated deficit position of 2,565.86 at Sept 2005 to an accumulated surplus of \$78,088.30 at Sept 2006. Most importantly, this surplus produced an improvement in the cash position of the Association to \$96,925.74 at Sept 2006 (compared to \$2,072.99 at Sept 2005).

With the expected earlier collections of part of the fees for next year, the improved cash position should enable the Association to manage its cash flow without having to make significant drawings on its limited overdraft facility over the summer period.

The improvement over last year is due to the increase in participation numbers and improvements in managing cash flow (billings, collections and payments).

In addition, it is worth noting that the previous debt to Soccer NSW, which related to underpayments made during previous years, has now been paid in full, as agreed with Soccer NSW. In addition, a provision has been made in the accounts for member bonds.

The main financial challenges for next year will be in managing the cost of Referees, managing costs related to changing the branding and marketing of the Association and managing cash flow.

In closing, I would like to thank Mark, Liz and Mel for the outstanding work they performed during the year.

The principal continuing activities of the company in the course of the financial year were the fostering and control of the game of association football within the boundaries of the Eastern Suburbs as determined by Soccer NSW. No significant change in the nature of these activities occurred during the year.

#### SIGNIFICANT CHANGES

In the opinion of the Directors there were no significant changes in the state of affairs of the association that occurred during the financial year under review not otherwise disclosed in this financial report

#### **RESULT FOR THE YEAR**

The operating surplus for the year was \$80,654.16

#### DIVIDENDS

The Memorandum and Articles of Association prohibit the payment of dividends, accordingly no dividend shave been provided for or paid during the financial year.

#### **REVIEW OF OPERATIONS**

The year in review shows an operating profit of \$80,654.16 bringing the association from an accumulated deficit position in 2005 of \$2,565.86, to an accumulated surplus in 2006 of \$78,088.30. Participation numbers have increased by 9.4% overall since 2005, with males increasing by 2.1% and females increasing by 51.46%.

#### AFTER BALANCE DATE EVENTS

In the opinion of the Directors no other matter or circumstance has risen since the end of the financial year that has significantly affected or may significantly affect:-

- I. The operations of the association;
- II. The results of those operations; or
- III. The state of affairs of the association

In financial years subsequent to this financial report

#### LIKELY DEVELOPMENTS AND RESULTS

There are no known likely developments, other than referred to in this report that would have a material impact on the association or its operations.

#### OPTIONS

No options to shares in the association have been granted during the financial year and there were no options outstanding at the end of the financial year.

#### **ENVIRONMENTAL ISSUES**

The associations operations are not regulated by any significant environmental regulation under a law of the commonwealth or of a state or territory.

#### 1 Statement of Accounting Policies

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, Urgent Issues Group Consensus Views and other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the Associations Incorporations Act (NSW).

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by the association in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

#### a) Income Tax

The association adopts the liability method of tax-effect accounting whereby the income tax expense shown in the statement of financial performance is based on the result from ordinary activities before income adjusted for any permanent differences.

Non-member income of the association is only assessable for tax, as member income is excluded under the principle of mutuality.

#### b) Property, Plant and Equipment

Property, plant and equipment are carried at cost, less where applicable, any accumulated depreciation or amortisation. The carrying amount of property, plant and equipment is reviewed annually by the committee to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

The depreciable amount of all fixed assets including capitalised leased assets, but excluding freehold land, are depreciated on a straight line basis over their estimated useful lives to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

c) Leases

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the entities within the economic entity are classified as finance leases. Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values.

Leased assets are depreciated on a straight line basis over their estimated useful lives where it is likely that the economic entity will obtain ownership of the asset or over the term of the lease. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

Lease incentives received under operating leases are recognised as a liability. Lease payments received reduced the liability.

#### d) Employee Benefits

Provision is made for the company's liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be settled within one year together with entitlements arising from wages and salaries, annual leave and sick leave which will be settled after one year, have been measured at their nominal amount.

Other employee entitlements payable later than one year have not been measured at the present value of the estimated future cash outflows to be made for those entitlements.

Contributions are made by the association to an employee superannuation fund and are charged as expenses when incurred.

#### e) Cash

For the purposes of the statement of cash flows, cash includes cash on hand and at call deposits with banks or financial institutions, investments in money market instruments maturing within less than two months and net of bank overdrafts.

#### f) Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

to the customers.

#### g) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

Football Vice President's Report

#### Introduction

2006 was a year where in my opinion 'improvement' was the key deliverable. Improvement in organisational structure, improvement in management processes, improvement in operational set up and implementation, improvement in communications and of course improvement in financial stability.

ESSFA entered into a new structure for 2006 and for me it proved a very successful and rewarding opportunity to manage football in the local area. Being the chairman of the Football Management Committee allowed me to concentrate on the football matters within the association and for me that is primary to what our association is for. Provide a competition structure for the football players within our association.

This does not come as easily as said. The management entailed everything from registration, competition structures and size, rules, regulations, referees, judiciary, youth league, grounds, dealing with council, dealing with Soccer NSW and much more. Not something that is easy to bring all together under one umbrella with approx 6500 players being members.

#### **Junior boys**

Our year consisted of our usual non competitive competitions for 6's through to 9's in the boys. This equated to 19 competitions and involves approx 1895 players. This is approx 50% of the junior boys total playing numbers and of course is the future for our sport in the area. This is the group that we must continue to sell our sport, our profile, and our future plans too, as this is where the next generation of volunteers and future coaches will come from, these players and their parents will be needed so as to continue to assist in the development of our sport in years to come.

In our competitive ranks we are in a position of strength also. From four divisions of U10's through to a very successful and very competitive U18s we have displayed a level of football that is competitive with other associations. Approx 1500 players play in these grades with our highest performing teams going on to represent the association at the Champion of Champions year end. This is also an area of growth considering years gone by when we have competed with joint age groups, we have grown this area to a point of single age competitions all the way from 13's to 18's. This all in a time when people doubted the strategy of bringing back age groups above 13's from Sunday to Saturdays.

These competitions helped produce what was a very successful grand final series, one that was played on some weekends under the most extreme conditions. My congratulations to all the competition winners and also to the grand final winners.

Again in this area we need to ensure that we provide competitive football and ensure that players at this level have every opportunity to develop to the best of their ability whilst also encouraging players to strive for the elite programs offered in the area. We have successfully moved some age groups back to Saturday (U13, 14 &15's) and the challenge will now be to

see if the 16's can move to again assist with impacts of Sunday football.

Football Vice President's Report

#### **Girls & Women**

The success story of the association in terms of football growth. My thanks to all the clubs who have helped implement junior girls & continue the growth in senior women's into the football family of the association. Special thanks to Maccabi and Easts for committing their junior girls into the association and increasing our numbers to a staggering 785 players in junior girls, EXCEPTIONAL and thank you. This will go a long way to increasing on the 27 teams (400+ players) currently competing in the senior women's competition and this again is an increase from 2006.

The level of competition within all the girls and women's competitions is increasing all the time and with this area of the sport developing more so than other areas, competition will continue to grow, improved coaching will come and more opportunities will open up for our female playing members.

The female base in our sport seems unstoppable in growth so we need to continue a high focus moving forward.

#### Men's

Eight open men's and two Over 35's sees our men's competition remain fairly stable from 2005. However the level of competitiveness seems to have increased at all levels. This is evident from the competition table year end and the quality of the finals series played at the Hensley in Aug /Sept.

1800 odd players compete weekly in our men's competitions and although I will leave the judiciary report to David, this is the area we must continue to drive in terms of more professionalism, better man management, more understanding and in the end less time spent on judiciary matters. This is a role model area as any senior league should be and one that demonstrates to the community how the game should be played.

Yes we would like more assistance with availability of referees and the Board is implementing strategic measures to assist in this area however some teams continue to defend their actions as "its just weekend football". Well weekend football does not use competition structures, web sites, judiciary panels, pay fees, organise grounds through council, pay insurance, have selected strips, pay referees etc etc. We are an organised sport and thus being organised means we need to organise in a professional manner and thus behave in a professional manner and this should be expected from our members as well.

I know most of our members agree with me and it is a matter of the association working with clubs and players to ensure they understand the role they play within the football community.






