Ranging from Covid-19 to illness to key staff, ESFA as an organisation had some disruptive events thrown our way; and I couldn't be prouder of the way that we reacted, pivoted and got the job done. As Charles Darwin noted, "it is not the strongest of the species that survives, nor the most intelligent that survives. It is the one that is most adaptable to change". This concept of adaptation is something that I will return to, but first, I would like to thank some key people.

To our Club volunteers, I cannot thank you or acknowledge your efforts this year enough. You are the heart and you are the soul of our game; and without you, this game does not exist. To the assorted Club Presidents, Secretaries, and Administrators that I have spoken to over the season, I appreciate your dedication to your membership. Every single interaction I have had with a Club this season has left me with no doubt that our Clubs are led by talented and passionate Administrators. Saying that, we as an Association must continue to ensure that we do not try and win games off the pitch. I was disappointed to observe that in a season where we should celebrate the fact that we even played football at all, Clubs were not able to put down their guns to cooperate for the greater good at times.

To our local Councils, thank you for your support in allowing us to push our season into mid-October and beyond in the case of our Men's and Women's Premier Leagues and O35 Championship, as well as working with us to facilitate an orderly return to community sport. I also applaud Randwick, Bayside and Waverley Council's for their waving of Ground Hire fees. A key feature of this season at the Board/Executive level was the relationship building that we saw across all our local Council partners and I hope we can continue to build on these relationships.

In looking back at the season, I believe we were able to lay the groundwork for operational/football excellence in seasons to come. Whilst some changes were incremental and others large, many were all built on the foundations of the recommendations that came out of the Club workshops last offseason and the direct feedback from Clubs. Whilst I don't intend to articulate all of our achievements here, there are two that I feel are worth highlighting.

The first is the creation of a Diversity and Inclusion Framework. The Framework will seek to outline how ESFA will continue to work to promote participation and engagement in Football across the diverse range of people that make up the Eastern Suburbs community. As part of our initial activities, ESFA formed a partnership with John Moriarty Football and was able to send Indigenous participants to Indigenous Football Week in Dubbo. The sending of participants to Indigenous Football Week was the culmination

of an 8 week process where ESFA hosted 'Come and try' sessions at no cost for Indigenous children at the National Centre of Indigenous Excellence in Redfern. ESFA will run similar 'Come and try' sessions through the offseason to drive growth in our female participation numbers for 2021 and beyond.



In addressing the second highlight, I want to return to the concept of adaptation that I mentioned earlier. The disruption that COVID-19 presented forced us to review our operational processes with a pressing urgency, and unfortunately, we found we were lacking in some areas. Therefore, I'm pleased to say that we are moving to an automated competition management system in 2021. Whilst it might not seem significant, an automated competition system will lead to significant efficiencies within the ESFA office. I recognise that the movement to a new system may be met with some trepidation, but I'm convinced that the long-term positives of the move will be transformative.

In closing, there is much that enthuses me as we look forward. Whilst I am proud of our efforts this year, I recognise that there is much to do. As a Board and Executive, we are committed and focused on delivering the best footballing product possible in 2021 and beyond for participants and volunteers in the Association. However, any steps forward need to be collaborative and require us all to lean in and put the interests of the Association first. This year highlighted how important football is beyond just the obvious physical benefits. Football establishes a sense of community, it provides a space for us to clear our minds and develop our self-worth, and it provides an avenue to form deeper connections with our friends. For me, it's these concepts that must drive our Association as we move forward. Because when it's all said and done, even though we're opponents on the field - we are all connected through our love of the beautiful game off it.

GENERAL MANAGER'S REPORT

This year has been a tough year both professionally and personally. Rolling into my second year at ESFA I was looking forward to a fantastic season of football. To say it turned out to be an unusual and 'hairy' season could be a bit of understatement.

This year has been a tough year both professionally and personally. Rolling into my second year at ESFA I was looking forward to a fantastic season of football. To say it turned out to be an unusual and 'hairy' season could be a bit of understatement.

Football for 2020 nearly did not get off the ground. COVID-19 created a lot of stress for families, businesses, sporting organisations - everyone. There was a strong possibility of the season not getting off the ground. If this had occurred, I feared that we would have potentially lost some Clubs and a couple of Associations in NSW. That is how drastic it could have got.

Drastic times bring the good out in human nature. The cooperation and teamwork by Football NSW, the Associations, the Clubs and the three levels of Government was fantastic. Football NSW under the stewardship of CEO Stuart Hodge displayed great leadership during the pandemic shut down. I must give a big wrap to the ESFA President Nigel Singh here as well, playing a lead role in certain areas with Stuart in getting through this stressful time which eventuated into a season of football.

I mentioned Government support. Without it (at all three levels) it would've have been a very stressful season, both financially and emotionally for ESFA and its member Clubs. As an example, Waverley Council, the City of Randwick and Bayside Council waived ground hire fees for pretty much the whole season. In fact I found it extremely heartening to see all of our Councils working with ESFA in ensuring we get a season of Football. To those folk I greatly thank. The Federal Government provided subsidies and tax credits which were an enormous help. The State Government provided a lot of support as well in terms of planning, execution and funds.

It was a trying time for ESFA staff, but we all managed to get through it. Thankfully we were able to keep all ESFA staff on board and ultimately deliver a crammed, but eventful season. Well done to all the staff. To Jaime Gomez, Caroline Oakes-Ash, Chelsea Brennan and Richard Beazley, their patience and their desire to deliver a great service in trying times could not be faulted. To our bookkeepers, Kilcran, especially Cici, our accounts are reported accurately and delivered well within timeframe.

The Clubs, especially the leadership displayed by the Presidents has been fantastic. They truly appreciated



what ESFA was able to deliver their members and in turn the Presidents, their Committees, Coaches and all their Volunteers went way beyond the cause in delivering a great football experience in 2020. It was no doubt a pressing year for our Volunteers having to implement all the initiatives that needed to adhere to the NSW Public Health Order. On the whole most spectators adhered to these as well.

I have really enjoyed working with all of the Clubs and I must say many see the big picture, which is gratifying. The relationship I have with many Clubs, especially the Presidents and some Committee people is extremely important, but also rewarding.

This year our pathways programs continue to grow. Our partnership with Sydney FC continued to grow through the delivery of Holiday Clinics, Skills Academy and School visits. With Sydney FC we share a Fan Development Officer. Alice Kriesler did a great job in kick starting all the programs and then Sarah Ferris took over and has continued the great work. ESFA and Sydney FC see this initiative as an important part of the football pathway for our young aspiring players.

Our Boys and Girls SAP continued to progress really well. This is an important program for our pathway. This year was the first year that ESFA had a Boys Youth League pathway - a partnership with NPL Club UNSW

FC. Under Jaime Gomez's leadership, persistence and expertise, this program exceeded all expectations. I am disappointed to report that UNSW FC has chosen to end our partnership. However, our SAP Boys do have NPL Clubs in close proximity they can kick on their aspirations in football as do the Girls.

Jaime's main focuses of course will still be the pathway, Coach Education and continually contribute to provide advice on competitions and their structures. Next season should see an ESFA Club SAP kick off.

Caroline and Chelsea did a great job in delivering competitions in 2020. Basically they were able to cram a near full season in three months. The work that they do is truly appreciated by many. The people that have a dig are the ones that do not provide solutions - so best to nod your head and move on!



As ESFA Referee's Coordinator, Richard Beazley had his challenges this year, but was able to overcome these. With COVID-19 many of his strategies were not able to be implemented this season, but will look forward to these coming into fruition in 2021. Because of COVID-19 we lost a few of our referees and HSC trial time had an impact on referee numbers. The Referees are an integral part of ESFA and we are fortunate to have many high level accredited referees on board.

To our sponsors we thank you for your understanding and professionalism. Bank of Sydney (ESFA Corporate Sponsor) will be doing a lot of work with ESFA in 2021 and a lot of their initiatives will benefit Club members. To Deploy (ESFA Ball Sponsor), they have been terrific - their quality and pricing is very good. John and his team at Jazzright Production Services (ESFA Events Sponsor) once again provided ESFA with excellent service. Finally, to Ultra Football (SAP Apparel Sponsor), our partnership with them continues to blossom.

The Financial position of ESFA improved a lot. However, a lot of this is due to the Govt. COVID-19 relief initiatives such as Job Keeper, providing Tax Credits as well as

Grants greatly assisted us. Some Sponsors paying in advance as well, saving a lot on Ground Hire costs which helped us immensely. The Treasurer's report will provide more detail.

Due to COVID-19 our player registrations took a bit of a hit, but all sports and community organisations suffered the same. Next season I expect our player numbers to grow a little, but we will still be missing the ex-pat market. Once normality fully sets in, then I expect our player numbers to at least last season's numbers.

The Board under Nigel Singh's Presidency is extremely supportive of not only me, but also our Clubs. They made and continue to make, decisions that are in the best interest of Clubs and their Members. Every Board member brings a different skill set which is very important. Example: Nigel with Business Strategy and Governance, Andrew Field with Technical Development, John Harris with Legal and Compliance, Jaleh Shafie with Competitions and Clubs, Roy Belcher with Facilities and Policies, Glen Overton with Competitions and Regulations, and Adam Hartas with Finance and Football Structure. Clearly a good blend of genuine people.

Facilities are always on the agenda. For ESFA to grow it needs a Home of Football. The Board and I have this as a priority. For our Member Clubs to thrive they need access to better facilities. Clubs such as Maroubra United (Coral Sea) and Pagewood Botany (Jellicoe) are thriving Clubs because one of the keys are their respective facilities. Together ESFA and its Clubs need to work in with Councils - and this has started.

I would like to thank Nigel and Roy for helping out in the ESFA Office due to my 'physical' absence. As some of you are aware I've been dished up with a health challenge which I am 100% positive of beating. To those who have touched base with me (many of whom on a regular basis) I sincerely thank you. To the staff, thank you for your support and professionalism. It is much appreciated. Finally, to the ESFA Board, thank you for your backing and kindness.

In conclusion, 2020 has been tough, but it has taught me especially that teamwork, camaraderie and basically the good nature of people working together, anything is possible. Bring on a more stable 2021.

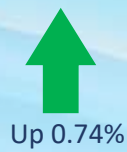

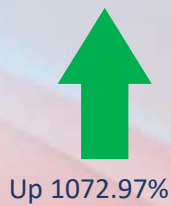
Total Revenue

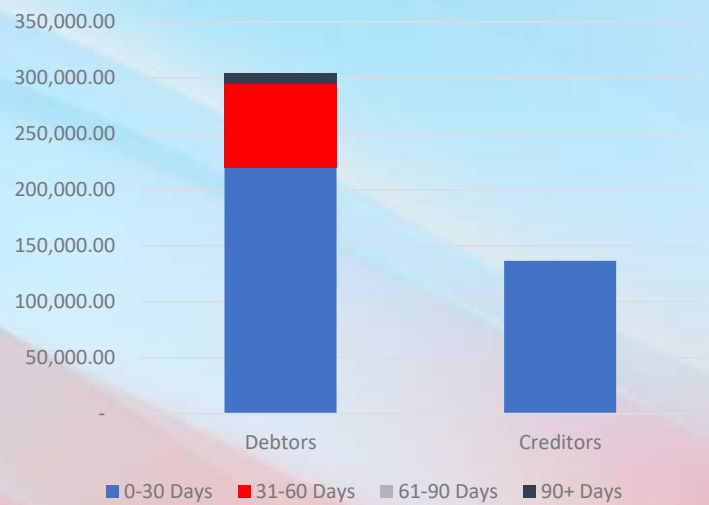
Total Expenses
\$1,405,946



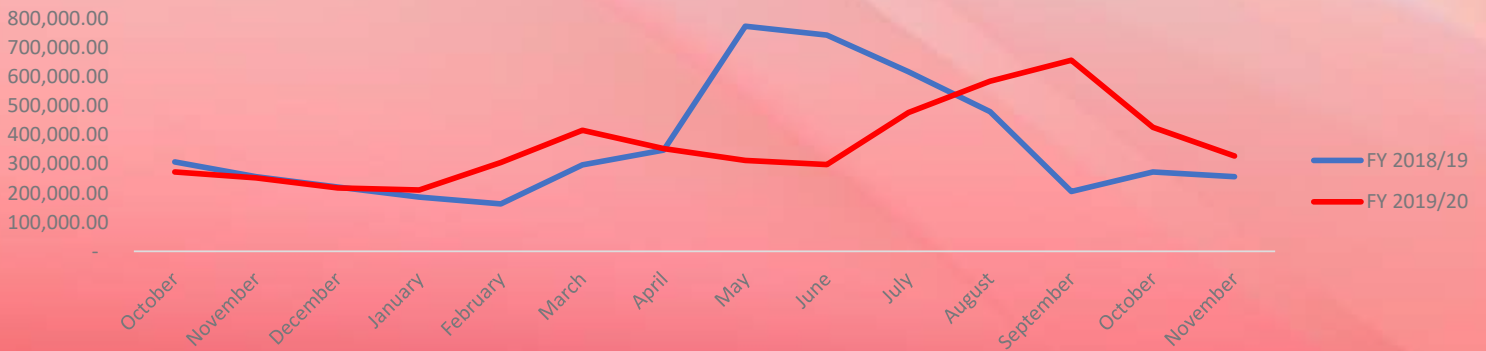
NET PROFIT

Principal Activities

The principal continuing activities of the association in the course of the financial year were the fostering and control of the game of association football within the boundaries of the Eastern Suburbs as determined by Football NSW.

Operating Result

The operating surplus for the year was : \$ 232,753

Significant Changes

No significant change in the nature of these activities occurred during the year.

After Balance Date Events

No matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the Association, the results of those operations, or the state of affairs of the Association in future financial years.

Likely Developments and Results

There are no known likely developments, other than referred to in this report, that would have a material impact on the association or its operations.

Eastern Suburbs Football Association Inc. Committees' Report

COVID-19 Impact

The COVID-19 pandemic developed rapidly in 2020 and caused enormous strain on our finances during Q2 of our Financial Year. The currently known impacts of COVID-19 on ESFA are:

- A decline of 809 registered players in 2020 compared with 2019 meant a loss of \$118,028 in player fees.
 - ESFA received \$154,984 in subsidies from State and Federal Governments.
 - ESFA made a saving of \$61,051 in employment costs due to the standing down of staff.
 - ESFA made a saving of \$88,563 in ground hire fees due to LGAs waiving ground hire costs.
- However, the Grand Final Ground Hire will be reflected in FY21 Financial Statements.


Whilst the savings from the above resulted in a strong operating profit for this period, there are many one-off savings that may not be available to ESFA on a go-forward basis. The non-recurring nature of the savings coupled with the meaningful loss in our core revenue lead the ESFA Board of Directors to take a conservative approach to our financial position moving forward.

Indemnifying Officers or Auditor

No indemnities have been given or insurance premiums paid, during or since the end of the financial year, for any person who is or has been an officer or auditor of the entity, other than as set out below.

During or since the financial year the Association has paid to Football NSW, premiums to insure all committee members against liabilities for costs incurred by them in defending any legal proceedings arising out of their conduct while acting in the capacity of committee member of the Association other than involving conduct involving a wilful breach of duty in relation to the Association.

Note 1: Statement of Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act New South Wales. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a) Income Tax

No provision for income tax has been raised as the entity is exempt from income tax under Section 50-45 of the Income Tax Assessment Act 1997.

b) Inventories

Inventories are measured at the lower of cost and net realisable value.

c) Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

d) Impairment of Assets

At each reporting date, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

e) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

f) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

g) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less.

h) Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

i) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

j) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

k) New accounting standards issued but not adopted

AASB 16: Leases (applicable to annual reporting periods commencing on or after 1 January 2019).

The main change introduced by the new standard is as follows:

- recognition of a right-of-use asset and liability for all leases (excluding short-term leases with less than 12 months of tenure and leases relating to low-value assets). Since the current lease is on a month to month basis, the directors have assessed that it is not applicable in these circumstances.





TECHNICAL DIRECTOR & COACHING AND TECHNICAL DEVELOPMENT DIRECTOR'S REPORT

Like many industries and environments, 2020 presented many challenges for the ESFA Technical Department. The sudden cessation of all football activity prior to the season commencing disrupted all planned coach education courses along with all club football and pathway programs. However, with the challenges presented it also allowed for opportunity and review on how we conduct our programs.

Prior to the imposed lock down, ESFA managed to support several member clubs by conducting community coaching courses and workshops, including the new Game Leader workshop designed to support our young game leaders tasked by clubs to support the Miniroos program. This gave ESFA the opportunity to deliver a consistent message on recommendations for how Miniroos should be played at each club. The club-based workshops were a success with participants gaining valuable guidance for the season ahead and sampling what a formal course may look like. However, many proposed courses had to be postponed due to the lock down. These courses restarted in late June and met the guidelines for COVID management mandated by the State Government, which limited the number of participants and how courses could be delivered. Despite this, ESFA delivered successful courses with many new and existing coaches attending the Grassroots and Skill Training Courses.

With the easing of restrictions, ESFA also confirmed its FFA/FNSW C-Licence which will be held in November of 2020, continuing into the new year.

There is a lot to look forward to in 2021 for Coach Education at ESFA. New initiatives such as a Female Only coaching course, online resources to be launched on the ESFA Website and further specifically targeted workshops, will be rolled out to further compliment the courses that are currently being offered.

ESFA continued its association and work with Sydney FC through the delivery of several Skill Training Programs, Holiday camps and its Schools program. The programs were overseen by Sarah Ferris the new Sydney FC/ESFA game development officer. These programs grew significantly and next year we look to expand the Skills Training Program utilising a new training venue and also conducting the first ESFA/Sydney FC Schools Cup. This initiative, in line with our Schools Program, will help promote football in the region and recruit new school age players into our member clubs.



ESFA also created two new programs, the ESFA Minis and the 'Come Try' program. The ESFA Minis program is aimed at our youngest footballers (u2-u5) giving them an introduction to football. Based on the registrations so far, 2021 will see this program increase offering more session times and availability.

The 'Come Try' program launched in conjunction with the National Centre of Indigenous Excellence (NCIE) is structured to provide an opportunity for young indigenous children to try football. The weekly session conducted by our expert ESFA coaches was held at NCIE in Redfern. Through this program, ESFA were able to send 2 young footballers to Dubbo to compete and represent ESFA at the Indigenous Football Week Gala Day coordinated by the John Moriarty Foundation. We look forward to supporting this program and growing it at several Eastern Suburbs locations.

Despite the season disruption, our ESFA SAP and Girls SAP teams performed exceptionally well under the guidance of our new SAP Technical Director, James Webb. Our young players showed their resilience in trying times and developed in the ESFA way. As always, many of our players who have graduated from our program will join NPL 1 and 2 teams to continue their footballing journey. The program is looking promising for season 2021 and we look forward to continuing to work with these talented young players. I would like to take this opportunity to thank all the coaches, managers and parents for their continued support for the program.

For the first time, ESFA ran a Youth League program in conjunction with UNSW FC and competed in the NPL 2 Youth competition. With only 6 weeks to set up all aspects of a Youth Club, ESFA can be very proud of its achievements. 64 players across the 4 teams were signed,



with the majority of players coming from the ESFA SAP program and the local member clubs. In a very short space of time in November 2020, ESFA recruited 8 coaches, 4 team managers and a youth convenor all managed through my role as Technical Director and supported by the ESFA office. A special thank you goes to Laura Ruvinsky (convenor) and Lucas Pacheco (Youth League Technical Director) for their guidance and care in this program. Unfortunately the UNSW FC committee has decided not to renew the MOU and will lead the program in 2021. We wish all the players joining or continuing in this program and the UNSWFC all the best.

2021 will see new programs and initiatives come to life, with the expansion of the Centre of Excellence. DISCIPLINARY REPORT

2020 once again was a challenge for the administration of the Judiciary. Match Official abuse decreased from 2019. Violent Conduct increased significantly from previous seasons.

There were 15 Club Citations, 14 Player Citations and 6 Coach Citations. There were 35 total incidents cited and in considering that 2019 which was a longer season had 38 citation hearings, this is disappointing as well as concerning.

Clubs were cited based on player, coach/RTO or spectator behaviour. Clubs must remember that fines and bonds may apply when dealing with disciplinary issues.

10 times hearing was requested from suspended parties. On average that meant 2 hearings a week with cited parties and requested.

One Appeal was held by ESFA.

Players were issued 182 red cards over the season based on the following codes:

REFEREES COORDINATOR'S REPORT

2020 has been an interesting season for all who are involved in football. We were lucky that we had a relatively full season of football compared to many other areas of Australia.

First and foremost I want to thank all of our referees who refereed during the season, especially those who helped cover many weeks of mid-week matches. Your hard work on and off the field meant we achieved a coverage rate of 87% of matches having a referee. Thank you.

I also want to thank the Clubs who helped getting players and teams onto the field, without you the season would not have been possible.

Level 4 Referee training courses were held in February and March with a total of 60 referees gaining their qualifications. In addition, Level 3 Referee and Level 2 (Theory) Referee upgrade courses were conducted.

I also conducted a Level 3 Instructor course which means four additional instructors are now able to run Level 4 and Level 3 Referee courses for ESFA.



The implementation of temporary dismissals for dissent was widened to include all adult competitions as well as U18 Boys. In 2019 we had a reduction of 45% in dissent within the Men's Championship competitions. 2020 saw a reduction of 20% in the number of cautions for dissent. While this is an improvement, more work is needed by all involved to reduce incidents where players or coaches show dissent towards a match official's decision by word and/or action.

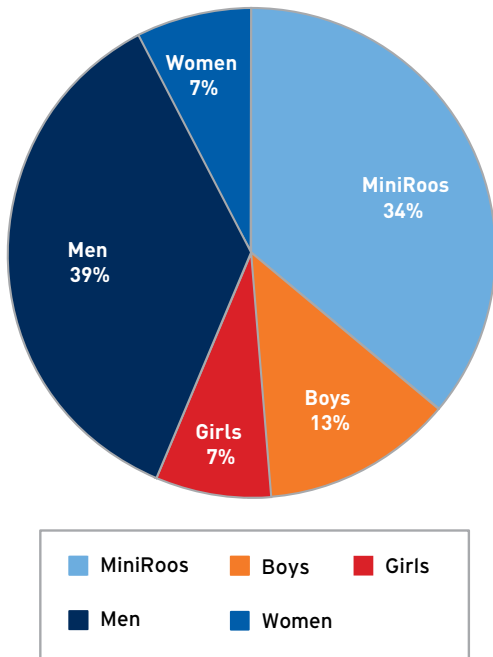

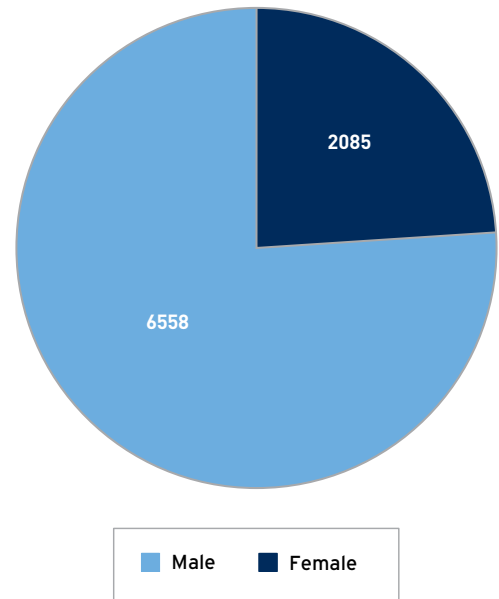

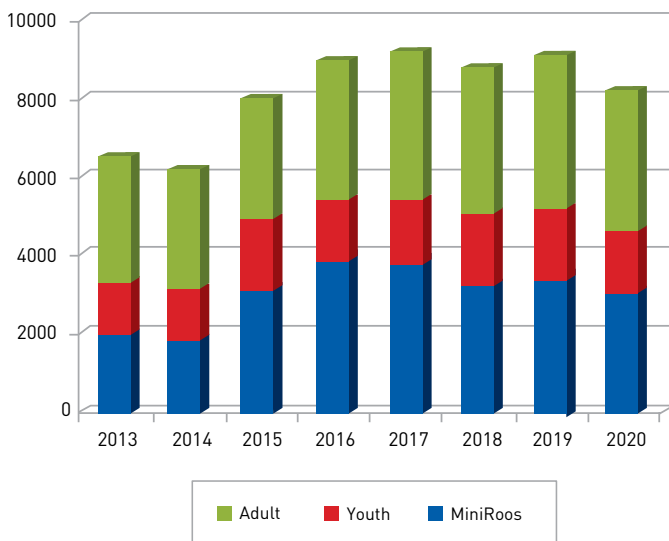
PARTICIPATION BY LEAGUE COUNCIL 2020



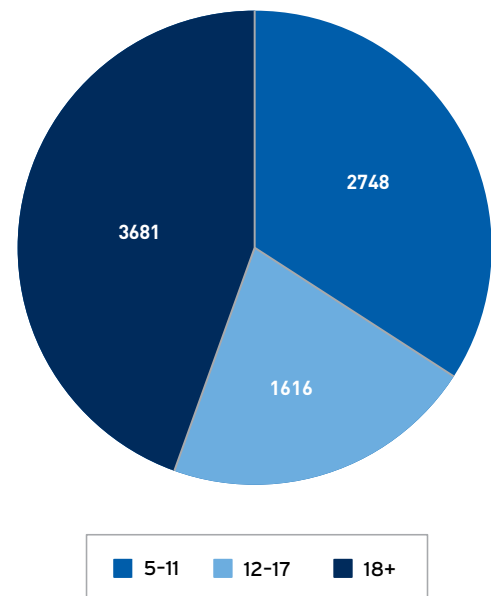
PARTICIPATION BY GENDER



PARTICIPATION BY SEASON

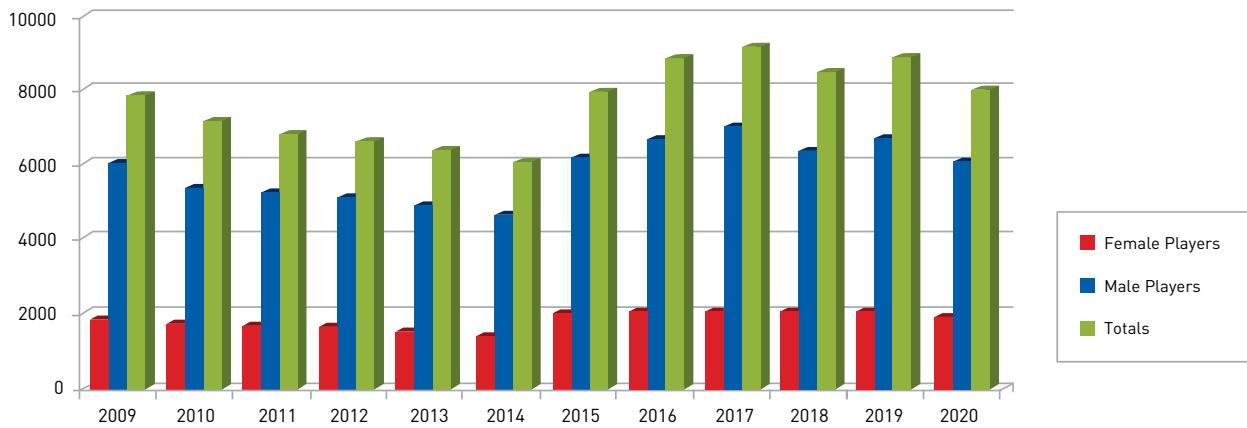


PARTICIPATION BY AGE CATEGORY



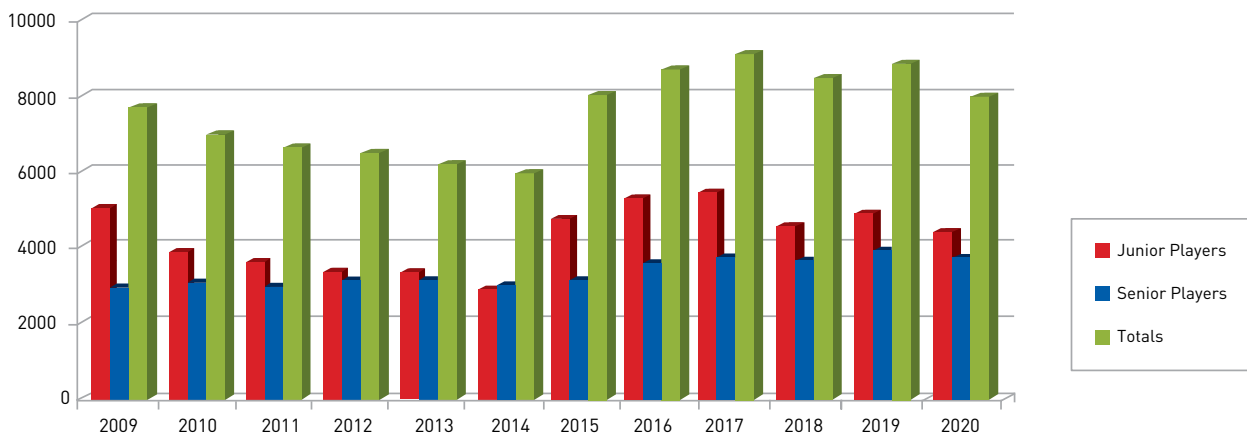

MALE VS FEMALE



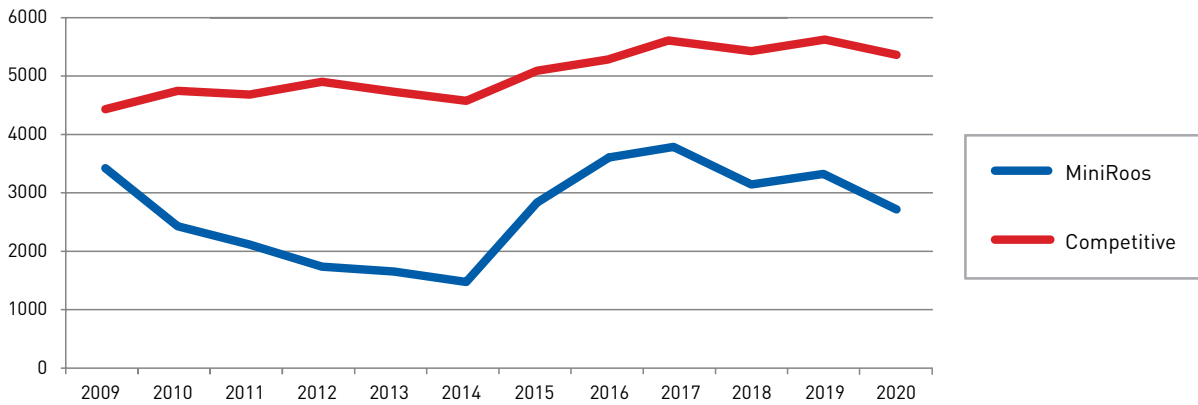
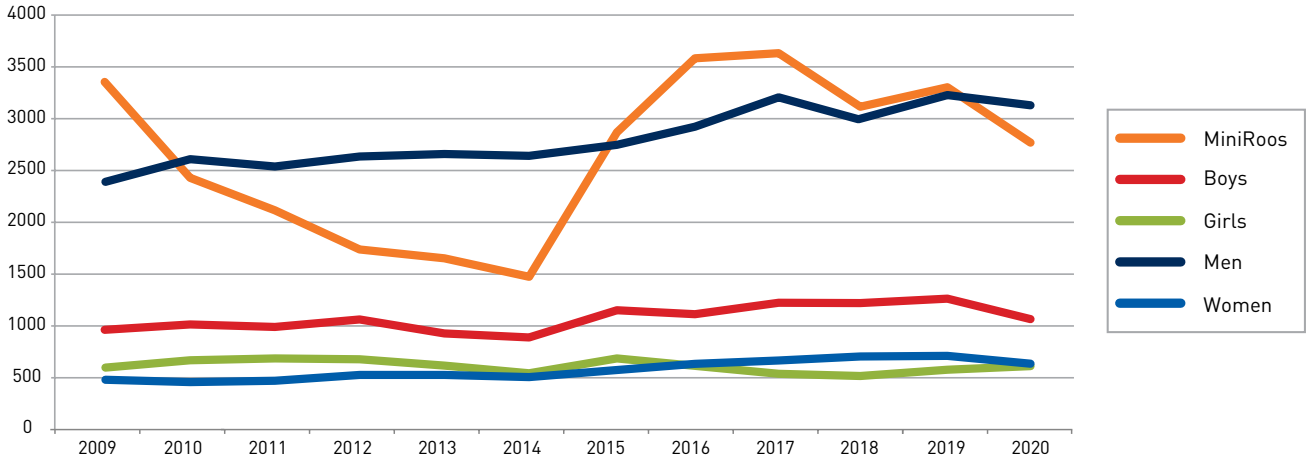
