8/21.6 Financials

ESFA Financial Update made by President. The President presented the latest version of the projected P&L for 2021-22. Assumptions were discussed e.g. Full wages for August and September, Ground Hire not finalised with Councils. Coaching fees stopped. Job Saver of \$5K factored in.

<u>Action</u>: BK to follow up with Cici to double check if ESFA can receive funding for loss of income. Currently ESFA cannot, but will check again.

Discussed player registration refunds for 2021. GDL not charged to registered players for 2021. Clubs have the direct relationship with the player. Currently nothing has been communicated by FA and FNSW re: player registration discounts.

E.g. Based on ESFA projections, ESFA look to provide a further 10% refund to Senior players i.e. \$11.90 per player. Clubs will be notified as well as individual players notified. Looking to break even for 2020-21. Final audited numbers will dictate.
