#### **DEVELOPING FOOTBALL FOR EVERYONE**

(Regulation pursuant to clause 36 of the Constitution)

Second or subsequent Offences: Where a Member has been found guilty of an Offence and then commits the same Offence on a second or subsequent occasion within two (2) years of the expiration of the Suspension issued in respect of the previous Offence, the second or subsequent Offence will be considered a Second or subsequent Offence for the purposes of sanctioning under Schedule H.

22	the successful completion of a referee's course and the requirement to officiate a number of matches
23	the compulsory attendance at a course(s) of education or rehabilitation (for example, an anger management course)
